

This will entitle you to be advised of a possible Ontario Municipal Board Hearing. Even if you are the successful party, you should request a copy of the Decision since the Decision may be appealed to the Ontario Municipal Board by the Applicant or another member of the public.

**IF a person or public body that files an appeal of a Decision** of the Approval Authority for the County of Bruce in respect of the proposed Consent does not make written submissions to the Approval Authority for the County of Bruce before it gives, or refuses to give, a provisional Consent, the Ontario Municipal Board may dismiss the appeal.

Any Person may make written submissions either in support or in opposition to the application.
