# WATER QUALITY

THE GOAL: IMPROVE LAKE WATER QUALITY BY REDUCING TOXIN LEVELS IN THE LAKE INCLUDING PPCP'S(Pharmacueticals and Personal Care Products).

- Fifth year of bio char program. Low cost solution with high removal efficacy.
- Purchase of 35 biochar bags this year. Over 100 biochar bags in the lake.
- 25 bags from last year removed from lake and placed in streams flowing into lakes 1, 2, 3 and 4.
- There are 6 bags in 4 cages in heavy flow areas and 12 bags place in various lake locations.
- Continue to test lake water to gauge the effectiveness of our efforts and broaden our testing for others hazardous elements.
- Thank you to the community for supporting this initiative through your personal purchases. Look for further detail to replenish in 2025.

#### WATER FOWL MANAGEMENT

#### THE GOAL: REDUCE TOXICITY OF FECAL MATTER IN THE LAKES AND RESIDENTIAL PROPERTIES.

- LRPOA and Brockton/Hanover Waste Management Committee have developed a collaborative plan aiming at seagull reduction.
- Abell Pest Control has been retained by Waste Management Committee for staff training of Mega Blaster Sonic Repeller and Pyro to move gulls away from Landfill site.
- Co-ordinated effort between landfill staff, Marl Lake and Lake Rosalind residents will include Mega Blaster, Pyro, Rocket Firecrackers and Laser Beam Strategies.
- LRPOA will continue to collect and discard geese eggs as per Canadian Wildlife Service. Collected over 120 eggs this spring. Imagine what the population of geese would be on the lake in three years time? 120 /2= 60 X 3 = 180 X3= 540 birds

#### WEED CONTROL

# THE GOAL: TO REDUCE THE SPREAD OF INDENTIFIED INVASIVE WEEDS AND CREATE WEED FREE AREAS FOR RESIDENTS

- Due to positive results from Weed B Gone mat implementation from residents last year, the LRPOA have purchased 6 mats to be installed in and around the channel into lake #3. Covering heavy growth area's.
- Over 50 additional mats have been purchased by residents. Thank you for participating in this control initiative.
- We look forward to hearing of your results.
- Plan for further implementation is 2025.

THE GOAL: Continue to promote Lake Rosalind as a community built around respectful and caring residents who want to live in a safe and family friendly community.

In addition: No consent will be provided by LRPOA Board of Directors without signing the liability waiver.
